OBJECTIVES:

- To clean and remove mould from interior of properties and prevent future re-growth.
- Eradicate musty smell and improve internal air quality.

English Rural Housing Association were looking for a solution for damp and mould issues in their rental properties.

They required a solution that wouldn't require tenants to vacate their homes for prolonged periods during treatment. Additionally, the solution needed to be safe for families and pets residing in the properties.

OUR APPROACH:

🛾 Locate 📋

We began with our Damp, Mould, and Condensation (DMC) assessment. Which considers property type, ventilation, insulation, heating, drainage, DPC, windows, and doors. This helped identify lifestyle factors requiring adjustment and essential building maintenance to prevent future mould growth post- treatment. Mould was detected in walls, ceilings, window seals, rafters, and insulation. We then provided a detailed report outlining affected areas and our recommendations.

Remove 😤

We then scheduled appointments with the tenants to tackle the mould issues. We began by misting our organic formula to safely eliminate hazardous mould spores. We then used specialised HEPA filter vacuums to remove dust, mould and bacteria debris. Our technicians then used our organic cleaner to remove visible mould and when necessary, we repainted the affected areas in preparation for the application of our barrier coating.

Protect W

We finished by applying our transparent surface barrier coating to affected areas. Our organic coating inhibits microorganism growth long-term. This combination disinfects and seals, guaranteeing mould prevention for at least 6 months, and potentially up to 2 years. Product longevity varies based on surface type and abrasion. On completion, we supplied a detailed report summarising the outcomes of the treated areas and procedures carried out.
